Citing Instructions

The Institute for National Security Studies (INSS) at Tel Aviv University invites submission of articles for our Journal *Cyber, Intelligence & Security*, a Peer Reviewed Journal, published three times a year in English and Hebrew. The Journal is edited by Dr. Gabi Siboni, Head of Cyber Security Program and Military and Strategic Affairs Program at INSS.

Footnote/Endnote Formatting

Footnote/endnote styles and formats vary, and different disciplines as well as different publications will choose particular note styles. Listed below are some general rules followed by examples of standard styles for INSS publications.

Notes in English

- Periods and commas are always placed inside quotation marks.
- Dates should be written as follows: month, day, year.
- When citing a newspaper article, the author and title of the article must appear as well as the name of the publication and the date.
- Article titles appear in quotation marks; book, journal, and newspaper titles are italicized.
- Website names are italicized.
- Radio and TV stations are not italicized.
- URLs should not stand alone; they supplement but do not replace standard documentation elements (author, article, source, etc.)

Authored Book

or with page numbers added:

Edited Book

Shlomo Brom and Anat Kurz, eds., *Strategic Survey for Israel 2009* (Tel Aviv: Institute for National Security Studies, 2009).

Article / Chapter in a Book

Yehuda Ben Meir, "Public Opinion and the Political Arena," in *Strategic Survey for Israel 2009*, eds. Shlomo Brom and Anat Kurz (Tel Aviv: Institute for National Security Studies, 2009).

or (preferably) with page numbers added:

Yehuda Ben Meir, "Public Opinion and the Political Arena," in *Strategic Survey for Israel 2009*, eds. Shlomo Brom and Anat Kurz (Tel Aviv: Institute for National Security Studies, 2009), pp. 15-28.

Monograph follows the same format for a book, with additional relevant information

Aron Shai, *Sino-Israeli Relations: Current Reality and Future Prospects*,

Memorandum No. 100 (Tel Aviv: Institute for National Security Studies, 2009).

Article in a Journal or Serial Publication

Ephraim Kam and Ephraim Asculai, "Countdown to the Iranian Bomb," *Strategic Assessment* 12, no. 4 (2010): 7-20.

In other words: Author(s), title in quotation marks, name of the journal in italics, volume number, followed by issue no. for that volume, year of publication in parentheses, followed by colon and then page number(s).

Emily B. Landau, "Friction in the Gulf: The Disputed Islands and Iran's Push for Regional Hegemony," *INSS Insight* No. 179, May 9, 2010.

Official publication of an organization (Firm, parliament, military, etc...)

"The U.S. Army Operating Concept: Win in a Complex World", *United States (U.S.) Army Training and Doctrine Command (TRADOC)*, 31 October 2014, pp 8-9.

In other words: title in quotation marks, name of the organization in italics, date, page number(s).

Article in a Newspaper

Article from the Internet

Giora Eiland, "Proximity Talks Doomed to Fail," *Ynet*, May 5, 2010,

Submitted articles should not exceed 6,000 words (including citations and footnotes).

Submitted articles should include an abstract (120 words) and Key-words (10 words).
