[The South China Morning Post, April 3, 2019] Polish Nationalists protest Holocaust Restitution Bill in N.Y.C. using anti-Semitic rhetoric Polish nationalists protested in New York City against a bill designed to help Holocaust survivors and their descendants reclaim lost property in Poland. Hundreds of people

participated in the protest and some employed anti-Semitic rhetoric. One protester held a sign calling to the "stop Holocaust industry," while others questioned how many Polish Jews were killed during World War II. The new law requires the U.S. State Department to report on how certain European countries have progressed in returning wrongfully confiscated or transferred Holocaust-era assets. It does not mention Poland specifically, but Poland is the only European country that has not passed laws to compensate those who lost their property and other assets during World War II. The decision is of crucial importance because, for the first time, a WTO dispute settlement panel ruled whether a country can use the Article 21 exemption to invoke national security as a justification for introducing trade restrictions that cannot be challenged by the affected state. During the meeting, it soon emerged that France was nearly isolated, with only a handful of member states, such as Belgium, sounding sympathetic to his arguments. EU says Italy's slower growth might trigger spending freeze Italy may be forced to freeze some of its planned public expenditures this year as the country's growth is slower than forecast, European Commission Vice President Valdis Dombrovskis said. Brussels had predicted in February a meager 0.2 percent expansion in Italy this year, but Dombrovskis said that growth could turn out to be "even slower" as global and domestic factors had dampened the outlook. A possible downward revision would further widen the gap with growth estimates made by Italy's eurosceptic government, which based its free-spending 2019 budget on the assumption of a 1 percent expansion. EU and Chinese officials meeting in Brussels proclaimed their summit as a win-win, but far more striking was the big loser: Donald Trump. European Council President Donald Tusk declared a "breakthrough" on some of the EU's major trade disagreements — including a joint pledge to back tough World Trade Organization rules on industrial subsidies. Commission President Jean-Claude Juncker said: "Today, we are making good on our joint commitment to uphold and to update the rules-based global order that has served us so well." And Chinese Prime Minister Li Keqiang, appearing at a news conference with Tusk and Juncker, declared the agreements reached at the summit "something good for China's reform and opening-up endeavors, and good for European unity and prosperity." Twelve Western nations urge Romania to ditch judicial changes Twelve Western nations urged Romania to scrap two planned emergency decrees altering judicial legislation, in a rare joint intervention that underlined U.S. and EU alarm over the threat to the rule of law. The embassies' joint statement coincided with a warning from the European Commission in Brussels saying it would take swift action against Romania if it failed to address its concerns over the independence of the judiciary. The decrees "apparently under discussion have the potential to impact on the independence of Romania's judiciary, which would undermine Romanians' and partners' trust in the justice system, and in Romania's government as well", they said. Merkel calls on EU to give UK more time on Brexit Angela Merkel has called on fellow European leaders to give the UK more time to avoid a disorderly exit from the EU, even as Theresa May repeated her desire for Brexit to be completed next month. In remarks that highlighted Berlin's conciliatory stance ahead of the crucial European summit on Brexit, Ms Merkel warned: "We have only 59 hours to avoid a disorderly UK exit from the EU. That scenario of a disorderly Brexit is not in our interest." Speaking to the German parliament, she said that the British prime minister had assured her during a visit "of her firm intention to find a way out of this situation together with the opposition in the House of Commons". [The Financial Times, April 9, 2019] JEWISH COMMUNITIES Genocide Research Institute in Lithuania publishes statement trivialising the Holocaust The Lithuanian Jewish Community expressed shock at an unsigned statement published by the Center for the Study of the Genocide and Resistance of Residents of Lithuania (LGGRTC), which reportedly seeks to remove the responsibility from the crimes committed by Lithuanian partisans in the Holocaust, and to justify the actions of Nazi collaborator Jonas Noreika. The statement by the LGGRTC also claims that "the number of Lithuanians who shot Jews was lower than in other nations" and that "the residents of occupied Lithuania in 1941 didn't understand ghettos as part of the Holocaust." [The European Jewish Congress, April 2, 2019] Report on 130 cases of Labour antisemitism shows the importance of Gordon Brown's unequivocal stand The writer examined more than 130 cases of antisemitism and antisemitism denial in the Labour Party recently, for a report published last week. The former prime minister has also produced a video in which he is emphatic about the approach Labour should be taking against antisemitism: "No ifs, no buts. no qualifications, no caveats." [The Independent, April 2, 2019] Dozens of headstones smashed at fire-ravaged Jewish cemetery in Romania Days after Romanian media reported about neglect at the Jewish cemetery of Husi in the country's northeast, 73 of its headstones were smashed in a suspected hate crime. The Fedrom umbrella group of Romanian Jews condemned the vandalism in a statement published Wednesday. "Such events of a profoundly anti-Semitic nature cannot be accepted in the democratic world, and seriously affect democracy in Romania," wrote Aurel Vainer, who heads Fedrom.
